AECOM is sending this e-mail to you as required by Item 7 of IEPA's April 9, 2014 letter (Log No. B-43R-CA-65, 68, and 76) and Item 7 of IEPA's May 15, 2015 letter (Log No. B-43R-CA-66 and 84). Item 7 requires that the IEPA Bureau of Land, Permit Section, and the Collinsville Field Office be notified by e-mail if the full-scale SVE system is down for more than 72 continuous hours. We are providing advance notice of shutdown of the SVE system which will exceed 72 hours. A Preventative Maintenance Evaluation of the RTO is scheduled for Tuesday and Wednesday September 26, and 27, 2017. In preparation for the maintenance activities, the SVE system was shut down at 3:00 p.m. on September 19, 2017 to allow the RTO unit to cool down. AECOM will notify IEPA when the system is brought back on-line.
