

AECOM Technical Services, Inc. (AECOM), on behalf of Equilon Enterprises LLC d/b/a Shell Oil Products US (Shell), currently submits the Roxana Interim Groundwater Monitoring Report on a quarterly basis. These reports include information required by Condition 7 of the Illinois Environmental Protection Agency's (IEPA's) letter dated August 5, 2010 (Log No. B-43R-CA-16 and -18). Condition 7.d. of the IEPA's August 5, 2012 letter provided the due dates for quarterly Roxana Interim Groundwater Monitoring Reports.

AECOM and Shell request to push back the due dates for each of these quarterly groundwater reports by approximately 2 weeks. The current due dates and proposed due dates are shown in the table below.

1 st Quarter	January-March	April 15	May 1
2 nd Quarter	April-June	July 15	August 1
3 rd Quarter	July-September	October 15	November 1
4 th Quarter	October-December	January 15	February 1

These modified due dates are proposed to allow more time for adequate compilation and quality review of the analytical samples and site data after the end of each quarter prior to report submittals. Please let us know if you are amenable to this proposal.
