On behalf of Equilon Enterprises LLC d/b/a Shell Oil Products US (Shell), AECOM Technical Services, Inc. (AECOM) is submitting this extension request for submittal of the report required by Conditions IV(1)(2) and V(D)(3)(iii) of Shell's Resource Conservation and Recovery Act (RCRA) Hazardous Waste Management Post-Closure Permit (Permit) [Log B-43R, most recently modified and reissued August 20, 2025]. These conditions allow for the combination of reporting for the following:


- 2<sup>nd</sup> Half 2025 (2H25) Corrective Action Plan (CAP) groundwater monitoring program at the WRB Refining LP Wood River Refinery (WRR); and
- 3<sup>rd</sup> and 4<sup>th</sup> Quarters 2025 (3Q25 and 4Q25) interim groundwater monitoring program in the Village of Roxana.

The combined report is due to the Illinois EPA by February 1, 2026, in accordance with Condition IV(1)(2) of the Permit. A one-month extension (to March 1, 2026) is being requested as this is the first time that the combination of these reports is being prepared, requiring additional reviews and quality checks to ensure its completeness and accuracy.

Copies of this extension request have also been issued electronically to Gary Ko, Dana Austin, and Ali Al-Janabi with IEPA.
