Dear Mr. Dyer:

The Illinois Environmental Protection Agency (“Illinois EPA”) acknowledges receiving your June 18, 2008 request for a meeting in response to the May 2, 2008 Violation Notice L-2008-01134. **The meeting is scheduled for Thursday, July 3rd, 2008 at 9:00 am at the Collinsville Regional Office at 2009 Mall St., Collinsville Illinois 62234.**

At the meeting there will be an opportunity to respond to each of the alleged violations, suggested resolutions, and suggested implementation time frames listed in Violation Notice, L-2008-01134, and to suggest alternate resolutions. Because you have requested a meeting, the Illinois EPA will make a decision on the June 18, 2008 proposed CCA and on the written meeting response within 30 days of receipt of the written meeting response [See Section 31(a)(7) of the Act].

Pursuant to Section 31(a)(5) of the Illinois Environmental Protection Act (Act) [415 ILCS 5/31(a)(5)], **within 21 days following the meeting, you must submit by certified mail to the Illinois EPA a written response to the alleged violations.** The written response must include:

1. Additional information in rebuttal, explanation or justification of each alleged violation;
2. A proposed Compliance Commitment Agreement (“CCA”) that includes specified time frames for achieving each commitment, and which may consist of a statement indicating that the person complained against believes that compliance has been achieved; and
3. A statement indicating that, should the person complained against so wish, the person complained against chooses to rely upon the initial written response submitted pursuant to

Failure to respond in accordance with the requirements of Section 31(a)(5) above will be considered a waiver of the requirements of Section 31(a), and the Illinois EPA may proceed with a referral to a prosecutorial authority.


Within 30 days of the Illinois EPA's receipt of the written response to the meeting, the Illinois EPA will provide in writing its acceptance, rejection, or proposed modification to the proposed CCA within the written response.
